SLOPE EASEMENT

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, LUIS P. CARRERAS and MAYRA CARRERAS, husband and wife, as Grantors, grant(s) to the CITY OF RIVERSIDE, a Municipal Corporation of the State of California, as Grantee, its successors and assigns, a perpetual easement and right of way for roadway slope and support purposes, in, on, under, through, over and along that certain real property situated in the City of Riverside, County of Riverside, State of California, described as follows:

The east 7 feet of the west 21.00 feet of Lot 5 of The Resubdivision of Arlington Suburban Estates, as shown by map of file in Book 13, Page 75 of Maps, records of said Riverside County; Excepting therefrom the southeasterly 62.50 feet of said Lot; said west 21.00 feet being measured at right angle 21.00 feet east from the west line of said Lot 5, and said southeasterly 62.50 feet being measured along the northeasterly line of said Lot.

Area - 531.72 square feet

Said slope and support easement is to be used for all purposes proper and convenient in the construction, reconstruction and maintenance of roadway slopes and supports, including the rights of ingress and egress, the temporary deposit of tools, equipment, machinery, vehicles, materials and supplies used in the performance of said work, and for similar and related purposes by the City of Riverside, its officers, employees, agents or contractors.

Provided, however, that the Grantor(s) reserve(s) the right of use and enjoy the land over which said easement and right of way is granted, for any purpose and in any manner which does not interfere with or impair the right of the Grantee to use said easement and right of way.
