BEGINNING at a point in the east line of Parcel 1 of Record of Survey on file in Book 42 at Page 73 of Records of Survey, records of said Riverside County, lying distant thereon North 00° 47' 22" East, 142.00 feet from the southeasterly corner of said Parcel 1;

THENCE North 44° 35' 46" West, along the northeasterly line of said Parcel 1, a distance of 11.24 feet to the north line of said Parcel 1;

THENCE North 89° 58' 46" West, along said north line, a distance of 7.73 feet to the beginning of a non-tangent curve, concave to the southwest, having a radius of 39.50 feet; the initial radial line at said beginning bears South 29° 09' 41" West;

THENCE southeasterly along said curve, through a central angle of 32° 29' 13", an arc length of 22.40 feet to said East line of Parcel 1;






