GRANT DEED

WHELCHER, husband and wife, as joint tenants, Grantors, FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, do hereby grant to the CITY OF RIVERSIDE, a municipal corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 2 in Block 23 of La Granada as shown by map on file in Book 12, Pages 42 to 51 inclusive, of Maps, records of Riverside County, California, described as follows:

BEGINNING at the most northerly corner of said Lot 2;

THENCE South 37° 25' 30" West, along the northwesterly line of said lot, a distance of 67.51 feet to the most northerly corner of that certain parcel of land conveyed to Gerry Oliver Baxter and Carole Jean Baxter, husband and wife, by deed and recorded October 21, 1964, as Instrument No. 127551;




