OFFER OF DEDICATION

On this 22 day of February, 1988, B. GEDNEY TILDEN, M. WILLIAM TILDEN, ARLINGTON HEIGHTS CITRUS COMPANY, a California corporation, and BURTON W. TILDEN and MARY G. TILDEN, husband and wife as joint tenants, as their individual interests appear of record, irrevocably offer for dedication to the CITY OF RIVERSIDE, a municipal corporation, pursuant to the provisions of California Government Code Section 7050, for public street and highway purposes, together with all rights to construct and maintain utilities, sewers, drains and other improvements consistent with the use as a public street and highway, that real property located in the City of Riverside, County of Riverside, State of California, described as follows:

PARCEL 1

That portion of Section 10, Township 3 South, Range 6 West of Rancho La Sierra Sepulveda, in the City of Riverside, County of Riverside, State of California, as recorded in Book 6, Page 70 of Maps, records of said County described as follows:

COMMENCING at the Southwest corner of Lot 1 of Sierra Vista Rancho Subdivision, on file in Book 25 of Maps, at Page 81 thereof, records of said County, said point being in a non-tangent curve concave northerly and having a radius of 1316.15 feet; the radial line to said point bearing South 12° 04' 14" East; said point also being in the southerly line of Lot "A" of Record of Survey on file in Book 10, Page 20, Record of Surveys, records of said County;
