

OFFSITE DRAINAGE EASEMENT

That portion of Block 28, Lot 1 of Block 29, and that certain unnamed street, known as Brown Street (vacated) adjoining the West line of said Lot 1, all being of the Alessandro Tract as shown by map on file in Book 6 of Maps, at page 13 thereof, Records of San Bernardino County, California, being a strip of land 52.00 feet in width, the centerline being described as follows:

Commencing at the centerline intersection of Bakal Drive and Yarrow Lane, as shown by Tract 22275-2, as shown by map on file in Book \_\_\_\_ of Maps, at page \_\_\_\_ through \_\_\_\_ thereof, Records of Riverside County, California;


Thence S.75°45'12"E. along the Southeasterly prolongation of the centerline of said Bakal Drive, a distance of 33.00 feet to the Easterly line of said Yarrow Lane;

Thence Northeasterly along said Easterly line on a non-tangent curve concave Northwesterly, having a radius of 1233.00 feet through an angle of 00°30'40", an arc length of 11.00 feet to the point of beginning of the centerline to be described (the initial radial line bears S.76°15'52"E.);

The sidelines of said strip of land 52.00 feet in width shall be prolonged or shortened as to terminate Northwesterly in the Easterly line of said Yarrow Lane;
