


CONSENT TO RECORDATION

PARCEL 1 (Eastridge Avenue)

That portion of Parcel 57 of Parcel Map No. 24733 lying westerly of the Metropolitan Water District of Southern California, Box Springs Feeder, as shown by map on file in Book 175 of Parcel Maps at pages 30 through 36 inclusive thereof, Records of Riverside County, California, described as follows:

Beginning at the northeast corner of Parcel 78 of Parcel Map No. 24535 as shown by map on file in Book 162 of Parcel Maps at pages 84 through 90 inclusive thereof, Records of Riverside County California;

Thence South $89^{\circ} 36' 20''$ West along the north line of said Parcel 78, a distance of 643.00 feet to a point therein;

Thence North $00^{\circ} 23' 40''$ West, a distance of 3.00 feet to a point in a non-tangent curve, concave to the north, having a radius of 947.00 feet, the radial line at said point bears South $00^{\circ} 23' 40''$ East;

Thence easterly along said curve, to the left, through a central angle of $09^{\circ} 26' 53''$, an arc distance of 156.16 feet to the end thereof;

Thence North $80^{\circ} 09' 27''$ East, a distance of 139.32 feet to the beginning of a tangent curve, concave to the south, having a radius of 1053.00 feet;

Thence easterly along said curve, to the right, through a central angle of $09^{\circ} 26' 53''$, an arc distance of 173.64 feet to a point of tangency with the south line of Parcel 17 of said Parcel Map No. 24733;

Thence North $89^{\circ} 36' 20''$ East along said south line and along the easterly prolongation thereof, a distance of 938.01 feet to a point in the northwesterly right-of-way line of said Metropolitan Water District of Southern California, Box Springs Feeder;

Thence South $51^{\circ} 01' 18''$ West along said northwesterly right-of-way line, a distance of 84.98 feet to a point in the south line of said Parcel 57;

Thence South $89^{\circ} 36' 20''$ West along said south line of Parcel 57, a distance of 694.32 feet to the point of beginning.

Thence southerly along said curve, to the left, through a central angle of $20^{\circ} 00' 00''$, an arc distance of 185.00 feet to the end thereof;

Thence South $20^{\circ} 31' 29''$ East, a distance of 131.64 feet to the beginning of a tangent curve, concave to the west, having a radius of 470.00 feet;

Thence southerly along said curve, to the right, through a central angle of $20^{\circ} 07' 49''$, an arc distance of 165.13 feet to the end thereof;

The last five (5) courses and distances follow the boundary line of said Parcel 56;

Thence South $00^{\circ} 23' 40''$ East along the west line of said Parcel 56 and along the southerly prolongation thereof, a distance of 568.41 feet;






