A. RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND DETERMINATIONS IN THE MATTER OF RESOLUTION OF INTENTION NO. 17836; RESERVING AND EXCEPTING EASEMENTS AND RIGHTS-OF-WAY AND DETERMINING THAT THE PUBLIC CONVENIENCE AND NECESSITY REQUIRE THE RESERVATION AND EXCEPTION OF SUCH EASEMENTS AND RIGHTS-OF-WAY; AND VACATING PORTIONS OF VARIOUS STREETS, ALLEYS AND RIGHTS-OF-WAY WITHIN PHASE I OF THE RIVERSIDE MARKET-PLACE SPECIFIC PLAN

WHEREAS on August 20, 1991, the City Council of the City of Riverside adopted Resolution No. 17836 declaring its intention to vacate portions of various streets, alleys and rights-of-way within Phase I of the Riverside Marketplace Specific Plan, referring to maps on file and fixing the date, hour and place of hearing pursuant to the Public Streets, Highways, and Service Easements Vacation Law, being Sections 8300 et seq. of Part 3 of Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS the proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside; and

WHEREAS notice of the hearing was given as provided by the Public Streets, Highways, and Service Easements Vacation Law; and

WHEREAS on the date fixed for the hearing the City Council heard the evidence offered by persons interested in the proposed vacation and considered the staff reports and the environmental assessment;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

1 1. The City Council hereby adopts the staff reports and
2 the environmental assessment as findings and further finds that
3 the vacation of portions of various streets, alleys and
4 rights-of-way within Phase I of the Riverside Marketplace
5 Specific Plan, as described in Exhibit A, attached hereto, will
6 not have a significant effect on the environment.

7 2. The City Council hereby finds, from all the evidence
8 submitted, that the streets, alleys and rights-of-way described
9 in Exhibit A are unnecessary for present or prospective public
10 use.

11 3. The City Council hereby determines that the public
12 convenience and necessity demand the acquisition, construction
13 and maintenance of a street of less than 40 feet in width.

14 4. The City Council hereby determines that the public
15 convenience and necessity require the reservation and exception
16 of certain easements and rights-of-way as reserved in Exhibit A.

17 5. The streets, alleys and rights-of-way described in
18 Exhibit A are hereby vacated, reserving and excepting from the
19 vacation the easements and rights-of-way reserved in Exhibit A.

20 6. The vacation shall occur only after the conditions
21 required by the City Council and on file in the Office of the
22 City Clerk have been satisfied. The City Clerk is hereby
23 instructed that this resolution of vacation shall not be
24 recorded until the conditions have been satisfied. Upon
25 satisfaction of the conditions, the City Clerk shall cause a
26 certified copy of this resolution of vacation, attested by the
27 City Clerk under seal, to be recorded in the Office of the

1 County Recorder of Riverside County, California. Upon such
2 recordation the vacation is complete.
