## EXHIBIT "A"

PARCEL 5A-1

That portion of Parcel 1 of Parcel Map as shown by map on file in Book 2 of Parcel Maps, at Page 40 thereof, records of Riverside County, California, described as follows:

BEGINNING at the most northerly corner of said Parcel 1;

THENCE South  $75^{\circ} 52' 29''$  East along the northeasterly line of said Parcel 1, a distance of 5.64 feet to an angle point therein;

THENCE South  $34^{\circ} 00' 00''$  East continuing along said northeasterly line, a distance of 143.80 feet to a point of cusp;






