TEMPORARY CONSTRUCTION  
EASEMENT

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, CLYDE F. HEASTON AND RUTH E. HEASTON, TRUSTEE U/D/T/ DATED SEPTEMBER 17, 1986, as Grantors, grant to the CITY OF RIVERSIDE, a municipal corporation of the State of California, as Grantee, its successors and assigns, a temporary easement and right-of-way for the construction and installation of slopes and storm drain facilities, together with all necessary appurtenances, in, under, upon, over and along that certain real property as described in Exhibit "A" attached hereto and incorporated herein by this reference, located in the County of Riverside, State of California.

Said temporary construction easement is to be used for all purposes proper and convenient in the construction and installation of slopes and storm drain facilities, including the rights of ingress and egress, the temporary deposit of tools, equipment, machinery, vehicles, materials and supplies used in the performance of said work, and for similar and related purposes by the City of Riverside, its officers, employees,

agents or contractors.

Upon completion of construction, the City of Riverside shall remove all debris, waste or excess material, brush or other matter or material deposited or placed upon the land, and with the exception of vegetation, return the surface as near as possible to its condition before construction.

This construction easement shall terminate upon completion of the work of constructing the slopes and storm drain facilities or within eighteen months of the date of recording this document, whichever occurs first.

## EXHIBIT "A"

That portion of the Southeast Quarter of Section 22, Township 3 South, Range 6 West, San Bernardino Meridian, as shown by Sectionalized Survey of the Rancho El Sobrante De San Jacinto, on file in Book 7 of Maps, at Page 10 thereof, records of San Bernardino County, California described as follows:

COMMENCING at a point in the southeasterly line of the right of way of the Riverside Water Company's Canal distant South 34°02'02" East (formerly recorded as South 33°46' East), 141.2 feet from the most easterly corner of that certain parcel of land conveyed to Florence M. Ware, by Deed recorded June 13, 1916 in Book 444, Page 103 of Deeds, records of Riverside County, California; said point being the most northerly corner of that certain property described in Document recorded February 4, 1991, as Instrument No. 39812 of Official Records of said Riverside County;

THENCE South 34°02'02" East, along the northeasterly line of said property described in Document recorded February 4, 1991, a distance of 23.15 feet to the POINT OF BEGINNING;

THENCE South 35°58'04" West, a distance of 91.68 feet to the southeasterly line of said Riverside Water Company's Canal Right of Way;

THENCE South 23°38'54" West, along said right of way, a distance of 56.05 feet;

THENCE North 43°56'19" East a distance of 136.52 feet to the northeasterly line of said property described in Document recorded February 4, 1991;

THENCE North 34°02'02" West, along said northeasterly line, a distance of 32.87 feet to said POINT OF BEGINNING.


