





BEGINNING AT THE INTERSECTION OF THE EASTERLY LINE OF MAIN STREET, 100 FEET WIDE, WITH THE SOUTHERLY LINE OF TRACT NO. 19220 AS SHOWN BY MAP THEREOF FILED IN BOOK 169 OF MAPS, AT PAGES 8 THROUGH 11, RECORDS OF SAID RIVERSIDE COUNTY;

THENCE SOUTH 60° 58' 09" EAST 143.19 FEET ALONG SAID SOUTHERLY LINE OF TRACT NO. 19220;
