FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, **RIVERSIDE COUNTY FEDERAL CREDIT UNION**, a non-profit organization, who acquired title as **RIVERSIDE COUNTY EMPLOYEES FEDERAL CREDIT UNION**, a non-profit organization, as Grantor, grants to the **CITY OF RIVERSIDE**, a municipal corporation of the State of California, as Grantee, its successors and assigns, an easement and right-of-way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement, relocation, renewal and removal of **electrical energy distribution facilities**, together with all necessary appurtenances, in, under, upon, over and along that certain real property located in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Block 13, Range 4 of the **TOWN OF RIVERSIDE** as shown by map recorded in Book 7, page 17 of Maps, records of San Bernardino County, California, described as follows:

BEGINNING at the most westerly corner of that certain parcel of land conveyed to the City of Riverside by deed recorded May 27, 1994, as Instrument No. 218347 of Official Records of Riverside County, California;


