

A STRIP OF LAND FOR PUBLIC ROAD AND INCIDENTAL PURPOSES OVER A PORTION OF THE NORTHEAST QUARTER OF SECTION 30, TOWNSHIP 3 SOUTH, RANGE 4 WEST, SAN BERNARDINO MERIDIAN, IN THE COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE EAST LINE OF SAID NORTHEAST QUARTER, BEING ALSO THE CENTERLINE OF WOOD ROAD, DISTANT SOUTH 00°03'35" EAST THEREON 660.02 FEET FROM THE NORTHEAST CORNER OF SAID NORTHEAST QUARTER;

THENCE SOUTH 89°32'04" WEST ALONG THE SOUTH LINE OF THE NORTH 660.00 FEET OF SAID NORTHEAST QUARTER 44.00 FEET;



**A RESOLUTION OF THE RIVERSIDE UNIFIED SCHOOL DISTRICT
GRANTING AN EASEMENT TO THE CITY OF RIVERSIDE FOR PUBLIC
STREET AND HIGHWAY PURPOSES ALONG WOOD ROAD AT HIGH
SCHOOL NO. 5**

WHEREAS, on the 21st day of July, 1997, the Board of Education duly adopted a Resolution declaring its intent to Grant an Easement to the City of Riverside for public street and highway purposes along Wood Road at High School No. 5, over a portion of the Northeast quarter of section 30, township 3 South, Range 4 West, San Bernardino meridian, in the County of Riverside, State of California, described as follows:

Beginning at a point on the East line of said Northeast quarter, being also the centerline of Wood Road, distant South $00^{\circ}03'35''$ East thereon 660.02 feet from the Northeast corner of said Northeast quarter;

Thence South $89^{\circ}32'04''$ West along the South line of the North 660.00 feet of said Northeast quarter 44.00 feet;

Thence South $00^{\circ}03'35''$ East along a line parallel with and 11.00 feet West of, measured at right angles to said centerline of Wood Road a Distance of 1327.06 feet to a point on the North line of the South 660.00 feet of the East half of said Northeast quarter;

Thence North $89^{\circ}27'41''$ East along said South line 44.00 feet to said centerline of Wood Road;


Thence North $00^{\circ}03'35''$ East along said centerline 1327.00 feet to the point of beginning of this description.

Except therefrom the existing right-of-way of Wood Road.

WHEREAS, this being the time for said public hearing, and hearing having been duly held and no protest having been made or entered;



We certify that the Resolution above was duly adopted by the Board of Education of the Riverside Unified School District at its Board meeting held on August 25, 1997.


