A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE STREET NAME OF SIEGAL AVENUE TO GROVE COMMUNITY DRIVE.

WHEREAS, Grove Community Church has requested a street name change from Siegal Avenue to Grove Community Drive, proposed in conjunction with the recently approved Grove Community Church development, approved in May, 2002 under, Zoning Cases CU-056-012, CU-057-012, CU-058-012, CU-059-012 and Vesting Tract Map TM 30508, which applications were approved by the City Council at its June 4, 2002 meeting; and

WHEREAS, the Planning Commission considered Case NC-001-012 at a public hearing held July 3, 2002 and approved the street name change of Siegal Avenue to Grove Community Drive on and forwarded its recommendation to the City Council; and

WHEREAS, on August 13, 2002, the City Council approved the name change;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, that the name of Siegel Avenue, described as:

That portion of Siegel Avenue bounded on the west by Trautwein Road and bounded on the east by the City Limits of the City of Riverside

as shown on the map in the attached Exhibit "A", and incorporated herein by reference, be changed to GROVE COMMUNITY DRIVE.

BE IT FURTHER RESOLVED that the City Clerk of the City of Riverside is authorized and directed to cause a certified copy of this resolution to be recorded in the office of the County Recorder of Riverside County, California.


