

TO THE CITY OF RIVERSIDE
PORTIONS OF PARCEL 2 OF LL-015-989**

Being a portion of the North half of fractional Section 33 and Section 34, T. 2 S., R. 6 W., San Bernardino Base and Meridian, as shown by Sectionalized Survey of Rancho La Sierra, of file in Book 6, Page 70 of maps, records of Riverside County, California;

Storm drain easement being a 20 foot wide strip of land, described as follows:

COMMENCING at the Southwest corner of Parcel 3, as shown by Lot Line Adjustment LL-015-989 recorded February 19, 1999 as instrument no. 67027 of official records of Riverside County, California, said point also being the West terminus of that certain course shown as N 77°03'12" E and having a length of 276.37 feet, as shown by said Lot Line Adjustment LL-015-989, said point being the beginning of a non-tangent curve concave Northeasterly, having a radius of 186.00 feet, to which point a radial line bears S 87°44'03" W;

THENCE, Southeasterly through said curve with a central angle of 32°05'31" a distance of 104.18 feet, to which point a radial line bears N 55°38'32" E;

THENCE, S 52°33'37" W, a distance of 28.04 feet, to the **TRUE POINT OF BEGINNING**, said point also being the beginning of a non-tangent curve concave southwesterly, having a radius of 214.00 feet, to which point a radial line bears N 55°14'19" E;


THENCE, Southeasterly through said curve with a central angle of 05°21'24", a distance of 20.01 feet;


