COUNTY OF RIVERSIDE)

For a valuable consideration Southern California Edison Company, a corporation organized under the laws of the State of California, with its principal place of business at the City of Los Angeles in said State, does hereby grant to the County of Riverside, an easement for public road and highway purposes in the following described real property in the County of Riverside, State of California;

A strip of land sixty (60) feet wide, lying thirty (30) feet on each side of the following described centerline;

Beginning at a point which is South 37° 49' West, a distance of 97.79 feet from the intersection of the centerline of Lakeview Avenue and the centerline of Arlington-Pedley Road, as shown on Sheet No. 2, Sparland Unit No. 6, recorded in Book 15 of Maps, Page 64, records of Riverside County, California. Said point being on the centerline of the Arlington-Pedley Road Station 51 + 74.1; thence along a curve to the left having a central angle of 116° 43', a radius of 200 feet for an arc distance of 407.42 feet; thence South 78° 54' East for a distance of 477.86 feet; thence along a curve to the right having a central angle of 22° 09' a radius of 400 feet for an arc length of 154.64 feet; thence South 56° 45' East, for a distance of 473.39 feet; thence along a curve to the right having a central angle of 55° 08' a radius of 250 feet for an arc length of 240.56 feet; thence South 1° 37' East for a distance of 469.21 feet; thence along a curve to the left having a central angle of 62° 43' a radius of 1000.3 feet for a distance of 480.06 feet to a point in the North line of the River Farm Tract which is South 66° 18' East a distance of 122.35 feet from the point marked (4) of Tract No. 1 of the said River Farm Tract as recorded in Book 7 of Maps, page 52, records of Riverside County, California.

Being more particularly shown in red color on plat attached hereto and hereby made a part hereof.

The aforesaid easement is granted subject to easements and encumbrances of record and subject to the right of said Southern California Edison Company, its successors or assigns, to construct, maintain, operate, alter, repair and/or remove transmission lines for electric energy and appurtenant structures over and across said and adjoining real property.
