We are most concerned with the construction of side inlets into the District's concrete lined trapezoidal channels during the rainy season. Such construction requires the removal of concrete panels which may result in considerable damage to our channels during a major storm event.

For this reason, Encroachment Permit No. 1-0-060-382, dated 1 October 1976, is hereby revoked. An amended encroachment permit is enclosed with a stipulation on the time when work can be performed.

PERMISSION IS HEREBY GRANTED TO the City of Riverside, Department of Public Works to construct into La Sierra Storm Channel, Stage "C", Jones Lateral, a 30-inch R.C.P. inlet and concrete spillway at Station 123+80. The work shall be performed as detailed on City of Riverside Storm Drain Plan and Profile, Tract No. 6992, Superior Street 20' Drainage Lot, Sheet 1 of 2.

Interfering portions of the 6-foot chain link fence shall be removed without cutting the fabric and replaced as directed by the Engineer.

All work within Riverside County Flood Control and Water Conservation District right of way shall commence after 15 April 1977.

The permittee's attention is directed to item 2 of the Special Provisions on the back of this form.

This permit is to be strictly construed and no work other than that specifically mentioned above is authorized hereby. Performance of the work shall be deemed to be acceptance by the Permittee of all terms and conditions of this permit.

This permit shall be void unless work herein contemplated shall have been completed before 1 November, 1977.

2. NO PRECEDENT ESTABLISHED. This permit is granted with the understanding that this action is not to be considered as establishing any precedent on the question of the expediency of permitting any certain kind of encroachment to be erected within right of way of the Riverside Flood Control and Water Conservation District.

3. KEEP PERMIT ON THE WORK. This permit shall be kept at the site of the work and must be shown to any representative of the Riverside County Flood Control and Water Conservation District.

4. PERMITS FROM OTHER AGENCIES. The party or parties to whom this permit is issued shall, whenever the same is required by law, secure the written order or consent to any work hereunder from the Public Utilities Commission of the State of California or any other public Board having jurisdiction, and this permit shall be suspended in operation unless and until such order or consent is obtained.

5. CLEAN UP RIGHT OF WAY. Upon completion of the work, all brush, timber, scraps and material shall be entirely removed and the right of way left in as presentable condition as before work started.

6. STANDARDS OF CONSTRUCTION. All work shall conform to recognized standards of construction.

7. SUPERVISION OF GRANTOR. All the work shall be done subject to the supervision of, and to the satisfaction of, the Riverside County Flood Control and Water Conservation District.

8. FUTURE MOVING OF INSTALLATION. It is understood by the Permittee that whenever construction, reconstruction or maintenance work on the right of way may require, the installation provided for herein shall, upon request of the Riverside County Flood Control and Water Conservation District, be immediately moved by, and at the sole expense of, the Permittee.

9. LIABILITY FOR DAMAGES. The Permittee is responsible for all liability for personal injury or property damage which may arise out of work herein permitted, or which may arise out of failure on the Permittee's part to perform his obligations under this permit in respect to maintenance. In the event any claim of such liability is made against the Riverside County Flood Control and Water Conservation District, or any officer or employee thereof, Permittee shall defend, indemnify and hold them and each of them harmless from such claim.

10. MAKING REPAIRS. The permittee shall replace and restore the right of way at the place of the excavation to its condition prior to the making of the excavation.

11. CARE OF DRAINAGE. If the work herein contemplated shall interfere with the established drainage, ample provision shall be made by the Permittee to provide for it as may be directed by the grantor.

12. MAINTENANCE. The permittee agrees by the acceptance of this permit to exercise reasonable care to maintain properly any encroachment placed by it in the right of way and to exercise reasonable care in inspecting for and immediately repairing and making good any injury to any portion of the right of way as a result of the work done under this permit, including any and all injury to the right of way which would not have occurred had such work not been done or such encroachment not placed therein.

13. PERFORMANCE WARRANTY. Bond may be required of the permittee whenever in the judgment of the Riverside County Flood Control and Water Conservation District, it becomes necessary or advisable to guarantee performance.

14. DURATION. This permit may be cancelled by the Riverside County Flood Control and Water Conservation District upon thirty days written notice to permittee.
