

- GENERAL NOTES**
1. EXACT LOCATION OF WYES TO BE DETERMINED IN THE FIELD.
 2. THE CONTRACTOR MAY USE PRECAST CONCRETE MANHOLE SECTIONS IN LIEU OF BRICK CONSTRUCTION.
 3. THE TOP RINGS OF THE MANHOLES SHALL BE OFFSET TO THE UPSTREAM SIDE AND TO CLEAR THE FUTURE C&G.
 4. WYES SHALL BE PLUGGED & CAPPED PER STD. DWG. NO. 562.
 5. PIPE SHALL BE BEDDED PER CASE I, STD. DWG. NO. 452, REV. I.
 6. FILL TO BE IN PLACE PRIOR TO SEWER CONSTRUCTION.

- SPECIAL WATER LINE ENCASEMENT NOTES**
1. CONTRACTOR SHALL NOTIFY THE CITY OF RIVERSIDE WATER DIVISION 48HRS. IN ADVANCE TO RAISE WATER MAIN.
 2. WATER MAIN SHALL BE ENCASED FOR A MINIMUM OF 3' ON EACH SIDE OF SEWER, PER STD. DWG. NO. 452, REV. I, CASE II.
